MEMORANDUM AND ORDER

(Request for Additional Extension of Time)

Cabot Performance Materials has now filed a fifth unopposed motion seeking yet an additional extension of the time within which to file its answer to the pending requests for a hearing in this matter involving its site decommissioning plan. The motion is granted in part.

While an extension to and including July 1, 2000, is now being sought, I am prepared at this juncture to extend the time only to Monday, April 3, 2000. Notwithstanding the recitations contained in the motion, I remain persuaded that, with the exercise of reasonable diligence, it should be possible to complete the information gathering activities that have now been in progress for a considerable period of time to allow meaningful settlement discussions to be completed by the latter date.

Should, nonetheless, yet another extension motion be forthcoming, I will expect it to set forth with considerable particularity the reasons why, notwithstanding the making of every reasonable effort to bring the settlement issue to an informed conclusion expeditiously, additional time beyond April 3, 2000, is still required.

No doubt, the interests of all concerned will be best served if a settlement is achieved and further adjudicatory proceedings thereby become unnecessary. There is thus good reason to accommodate the desire of the parties to have sufficient opportunity to endeavor to achieve a settlement. But there is also good reason why this matter should not remain indefinitely on the Panel's docket simply because none of the parties perceives any sense of urgency in pursuing settlement possibilities.

One final matter. 
