**APPLICANT'S SUPPLEMENTAL DISCOVERY RESPONSES TO THE
STATE OF UTAH'S EIGHTH AND NINTH SETS OF DISCOVERY REQUESTS**

Applicant Private Fuel Storage L.L.C. ("Applicant" or "PFS") files this Supplemental Discovery Response to the State of Utah's Eighth and Ninth sets of discovery requests pursuant to the Atomic Safety and Licensing Board's March 10, 2000 Memorandum and Order ruling on discovery disputes between PFS and the State of Utah. As allowed by the Board's Memorandum and Order, the State and PFS agreed to an extension of the deadline to March 31, 2000 for answering discovery to which the Board had ordered PFS to respond. The State and PFS also agreed that PFS would answer at the same time other discovery requests to which PFS had initially objected but had subsequently agreed to answer in negotiations between the State and PFS.


