In accordance with Section B.2 FAR Clause 52.212-4(c), Contract Terms and Conditions—Commercial Items, the purpose of this modification is to reduce the level of effort and change the unit from a fixed price monthly rate to a fixed price hourly rate. Accordingly, the contract is modified as follows:

- (1) **Item No.004 under No. 19 on Optional Form 348** is deleted entirely and replaced with the following:

- (2) **Paragraphs "a" and "b" under Section B.1.3, Personnel Requirements** are deleted entirely and replaced with the following:

- a. The Contractor shall provide one part-time qualified Data Entry Personnel. To facilitate the resolution of administrative matters involving personnel, the Contractor shall provide a Supervisory point of contact for the NRC Project Officer.
- b. Personnel shall work 20 hours per week exclusive of federal holidays. Work schedules, while flexible, shall be approved in advance by the NRC Project Officer. Any changes to the work hours shall be approved in advance by the NRC Project Officer. Work shall begin at 8:00 a.m. and end at 4:45 p.m. These hours coincide with NRC Region III's core business hours.

All other terms and conditions, including the ceiling amount of \$316,354.31, remain the same.

This modification does not obligate any funds.
