The purpose of this modification is to 1) Extend the period of performance of the contract from March 28, 2000, through April 28, 2000, and 2) Increase the ceiling of the contract by \$16,073.95 from \$259,830.00 to \$275,903.95. Accordingly, the contract is hereby modified:

1. Standard Form 26, Item 15G, Total Amount of Contract, is deleted and substituted with the new amount of "\$275,903.95."

2. Section F, Subsection F.2 entitled, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), is deleted in its entirety and substituted with the following in lieu thereof:

"This contract shall commence on September 28, 1998, and will expire on April 28, 2000."
