

W.M.Schlosser is hereby directed to give immediate effect to the seventh floor architectural, mechanical and electrical changes identified below. All work is to be performed in accordance with the base contract specifications except as noted herein. Modifications should be recorded in the As-Built drawings.

**MECHANICAL CHANGES**

1. Relocate six (6) thermostats.
2. Relocate two (2) supply outlets.

**ELECTRICAL CHANGES**

**ADDS**

1. Relocate seven (7) lights.
2. Install seven (7) additional Transwall switches.
3. Install one (1) additional eight conductor furniture drop.
4. Provide forty-four (44) 90" connectors.
5. Relocate one (1) junction box.
6. Install additional electrical wiring in four (4) locations.

**DELETES**

1. Delete seventeen (17) duplex outlets (drops).
2. Delete thirty-nine (39) duplex outlets (extensions).
3. Delete ten (10) single outlets.
4. Delete ten (10) furniture outlets (labor only).

**ARCHITECTURAL CHANGES**

1. Box-out thirty (30) feet of above ceiling obstructions.

W.M. Schlosser is requested to provide a proposal for adjustment within twenty calendar days of the effective date of this change order. Upon completion of negotiations, a supplemental agreement will be issued to incorporate an equitable adjustment for these changes.

Except as provided herein, all other terms and conditions remain unchanged and in full force and effect.
