The purpose of this modification is to: (1) cancel Modification No. 22 under the subject contract and replace with Modification No. 23 to decrease the contract obligated amount by \$47.78 from \$804,931 to \$804,883.22, and (2) decrease the contract ceiling by \$47.78 from \$804,931 to \$804,883.22 for final contract closeout. Accordingly, the contract is modified as follows:

1. Under Section B.3, CONSIDERATION AND OBLIGATION-Cost Reimbursement (JUN 1988), Alternate I, paragraphs (a) and (b) are deleted in their entirety and the the following paragraphs are substituted in lieu thereof:

- "a. The total estimated cost to the Government for full performance of this contract is \$804,883.22.
- b. The amount obligated by the Government with respect to this contract is \$804,883.22."
