SUBJECT: MODIFICATION NO. 12 TO INTERAGENCY AGREEMENT NO.  
NRC-09-93-233 ENTITLED, "NUCLEAR SAFETY ATTACHE POSITION  
AT U.S. MISSION IN VIENNA"

Dear Mr. Simpson:

The purpose of this modification is to (1) revise Article II - Payment by the NRC to DOS - to incorporate additional billing requirements for the Department of State (DOS), (2) increase funding by \$11,695 to Job Code E7032, BOC 251B to provide funds for FY 1999 services provided under Reimbursement Agreement No. 9200.0019 1 dated August 2, 1999, (3) increase funding by \$12,038 to Job Code E7032, BOC 251B to provide funds for FY 2000 services as reflected in the DOS-ICASS budget dated 12/1/99, and (4) revise Article IV - Points of Contact.

Therefore, the following paragraph is incorporated at the end of Article II of the above subject interagency agreement as follows:

Article II - Payment by the NRC to DOS

"DOS is required to submit the Target Budget, Original Budget, and Mid-Year Budget Reports to the following NRC contacts: (1) Contract Specialist, Division of Contracts and Property Management, and (2) NRC Project Officer (see Article IV below for names/addresses). These reports shall detail the anticipated costs for each fiscal year. To avoid the cost exceeding the stated ceiling amounts obligated under the interagency agreement, DOS is required to notify the NRC Contracting Officer in advance if allocated funds will be insufficient to cover the anticipated costs (see Article IV below for name/address)."

Therefore, Article III of the above subject Interagency Agreement is modified as follows:

Article III - Funding Limitations

1. The total estimated amount of this Agreement for the one year period of performance (October 1, 1998 through September 30, 1999) is \$189,595.


