The purpose of this modification is to add the NRC Technical Training Center (C-TN) in Chattanooga, TN, as an additional location for presentation of the training courses as required under the subject contract. Note: The courses taught at C-TN are to be covered by funding currently existing under the contract and no additional funds will be added under this modification. Accordingly, the following changes are hereby made:

A. Under Section B.3.12, General Information, subparagraph (b)(1) is deleted in its entirety and revised as follows:

- (1) "Courses will typically be conducted at the NRC Headquarters, Rockville, MD or at/near one of the NRC regional offices in King of Prussia, Pennsylvania (Region I); Atlanta, Georgia (Region II); Lisle, Illinois (Region III); Arlington, TX (Region IV); and the NRC Technical Training Center (C-TN), Chattanooga, TN."

B. Under Section B.8, "Supplies of Services and Prices/Costs," add an additional location for training courses to be presented at the NRC Technical Training Center in accordance with the contractor's proposals dated 2/14/00 and 2/28/00 as follows:
