The purpose of this modification is to exercise Option Year 3 in accordance with Section I.4 and increase the ceiling amount by \$229,536.18 from \$662,689 to \$892,225.18. Accordingly, the contract is hereby modified as follows:

Section F.6, Duration of Contract Period (Mar 1987) Alternate 4 (Jun 1988), is deleted in its entirety and replaced with the following:

"The period of performance shall commence on March 19, 1997 and continue through March 18, 2001."

All other terms and conditions of the contract remain unchanged.
