

The purpose of this modification is to provide incremental funding in the amount of \$5,000.00, thereby increasing the contract's obligated amount from \$105,000.00 to \$110,000.00. Accordingly, the contract is hereby modified as follows:

Under Subsection B.10 entitled "CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988)," the first sentence in paragraph (b) is deleted in its entirety and the following sentence is substituted in lieu thereof:

"The amount presently obligated with respect to this contract is \$110,000.00."

All other terms and conditions of this contract remain unchanged, including the ceiling amount of \$154,640.00.
