(Responses to PFS Reconsideration Motion)

Upon consideration of the June 13, 2000 motion of applicant Private Fuel Storage, L.L.C., (PFS) for reconsideration of that portion of the Licensing Board's June 12, 2000 memorandum and order that denied a May 31, 2000 PFS motion to strike certain portions of the testimony of intervenor State of Utah's (Utah) witness Michael F. Sheehan, Ph.D., on contention Utah S, Decommissioning, it is

ORDERED, that any party written responses to this motion shall be filed on or before Friday, June 16, 2000. The filing permitted under this order should be served on the Board, the Office of the Secretary, and counsel for the other participants by facsimile transmission, e-mail, or other means that will ensure receipt by noon Mountain Daylight Time on the day of filing. Conforming paper copies of these submissions should be (1) sent to the Office of the Secretary, the Board members, and the parties by first-class mail; and (2) distributed on Monday, June 19, 2000, prior to the start of the evidentiary hearing to the Board members and those parties in attendance.

The parties are advised that the Board will provide a brief opportunity for argument regarding the pending PFS reconsideration motion at the beginning of the Monday, June 19, 2000 hearing session.

In addition, the parties are advised that the Board will entertain brief opening statements by the parties, if they wish to make such a statement, summarizing their position regarding each of the three contested issues in the proceeding. Parties have the option either of making one statement at the beginning of the proceeding regarding all issues or making a statement as to each issue prior to the beginning of the evidentiary presentation on that issue.
