
Dear Administrative Judges:

In accordance with the Board's Order of June 12, 2000 at 8 (electronic version), the State submits the enclosed alphabetical list of those individuals who may attend on behalf of the State the closed hearings to be held in Salt Lake City beginning June 19, 2000. This list contains three persons whose names did not appear on the State's original list submitted May 15, 2000; they are Gary B. Doxey, John A. Harja, and Matt A. Crapo.

Further, the State informs that its testifying witnesses for Contention Utah H, Dr. Marvin Resnikoff and Matthew Lamb, will not be attending the closed hearings, since the State will not be going forward with Utah H, and thus, their names have been removed from the attached list.

Finally, in reference to the Board's Order relative to individually executed nondisclosure agreements (Order at 8 and n. 3), the State advises the Board that its Confidentiality and Nondisclosure Agreement with PFS (July 14, 1998) permits State-designated persons access to PFS proprietary information on a need to know basis, and does not require that each individual execute a separate nondisclosure statement. However, the State will take steps to remind the individuals on the attached list of their obligations to hold in confidence and not to disclose the proprietary information as required by the terms of the State/PFS Agreement.
