Intervention Petition Supplement)

Upon consideration of the February 2, 1998 amended late-filed intervention petition of Scientists for Secure Waste Storage (SSWS); the February 10, 1998 notice of appearance of SSWS counsel; and the February 13, 1998 responses of applicant Private Fuel Storage, L.L.C. (PFS), petitioner State of Utah (State), petitioner Ohngo Gaudadeh Devia (OGD), petitioner Skull Valley Band of Goshute Indians, and the NRC staff, it is

ORDERED, that petitioner SSWS shall have up to and including Friday, February 27, 1998, within which to file a final supplement to its intervention petition, which must include a list of contentions and supporting bases; and it is

FURTHER ORDERED, that any participant wishing to file a response to any final intervention petition supplement submitted by SSWS shall do so on or before Monday, March 9, 1998.
