Upon consideration of (1) the November 1, 1999 joint report of applicant Private Fuel Storage, L.L.C. (PFS), intervenor State of Utah (State), and the NRC staff regarding a schedule for the evidentiary hearing for contention Security-C; and (2) the November 10, 1999 joint report of those parties regarding litigation of contentions involving 10 C.F.R. § 2.790 proprietary information, it is ORDERED, that the schedule in connection with the evidentiary hearing on contention Security-C will be as follows:

FURTHER ORDERED, that the evidentiary hearing regarding contention Security-C will begin on Tuesday, March 14, 2000, at 9:00 a.m. EST, at the Atomic Safety and Licensing Board Panel Hearing Room, Room T-3B45, Two White Flint North Building, 11545 Rockville Pike, Rockville, Maryland; and it is

FURTHER ORDERED, that because the hearing regarding this contention is likely to involve evidence concerning 10 C.F.R. Part 73 "safeguards information," in accordance with the Board's December 17, 1997 protective order (1)

attendance at the hearing will be limited to those PFS, State, and NRC staff counsel, experts, and staff who have a "need to know" relative to the litigation of contention Security-C; and (2) on or before Tuesday, February 29, 2000, PFS, the State, and the staff shall each provide the Board with a list of those individuals who will attend the hearing on its behalf.²

With regard to the conduct of closed hearings on contention Utah H, Inadequate Thermal Design, contention Utah GG, Failure to Demonstrate Cask-Pad Stability During Seismic Event for TranStor Casks, and any other contention that may involve 10 C.F.R. § 2.790 propriety information, the Board adopts the parties suggestion that (1) any closed proceedings regarding proprietary information be held at the same place and in conjunction with any nonproprietary portion of the hearing regarding those contentions; and (2) any determination regarding closing portions of the hearing

be made after prefiled testimony is submitted relative to the contentions involved.


