(Ruling on Extension Motion)

Upon consideration of the July 21, 2000 motion of intervenor State of Utah (State) requesting an extension of time within which to file proposed findings of fact and conclusions of law regarding contention Utah R, Emergency Plan, including its representations concerning the positions of applicant Private Fuel Storage, L.L.C., (PFS) and the NRC staff relative to the State's motion, it is

ORDERED, that the State's July 21, 2000 motion is granted in part in that the parties shall have up to and including Monday, August 7, 2000, within which to file their proposed findings of fact and conclusions of law regarding contention Utah R.

This extension of time does not affect the July 31, 2000 due date for the parties' proposed findings of fact and conclusions of law relating to contentions Utah E/Confederated Tribes F, Financial Assurance, and Utah S, Decommissioning, or the August 28, 2000 due date

for the parties' responses to the proposed findings of fact and conclusions of law for all three contentions.
