Pursuant to my authority under 10 C.F.R. §§ 2.1312 and 2.772(k), I direct the applicants to file, within five working days of the date of this order, a status report on their transfer-related proceedings before the Vermont Public Service Board (VPSB), the Federal Energy Regulatory Commission (FERC), and any other governmental entity, and also a status report on AmerGen's private letter ruling request to the Internal Revenue Service (IRS) regarding the tax consequences of acquiring the decommissioning trust funds for the Vermont Yankee and other plants. Applicants are further directed to provide the Commission, during the remainder of the instant proceeding, with copies of any orders issued by VPSB, FERC or other governmental entities regarding the applicants' transfer-related proceedings, as well as any letter rulings from the IRS in response to AmerGen's above-referenced request.
