Dear Mr. Kingsley:

On June 28, 2000, the NRC completed an inspection at the Braidwood 1 and 2 reactor facilities. The enclosed report presents the results of that inspection. The results of this inspection were discussed on June 28, 2000, with Mr. Tulon and other members of your staff. Please note that this inspection was not part of NRC's new Reactor Oversight Program, rather as discussed with your staff it was a follow-up to a previously conducted core and Operational Safeguards Response Evaluation inspections.

The inspection was an examination of activities under your license as they relate to a change in your protective strategy for protecting against the NRC design basis threat. The inspection consisted of table top drills and actual exercises demonstrating implementation of your new defensive strategy. No significant findings were identified

SUMMARY OF FINDINGS

Braidwood Generating Station, Units 1 and 2
NRC Inspection Report 50-456/2000010(DRS); 50-457/2000010(DRS)

This report covers a three day "Regional Assist" inspection by a regional security specialist, a reactor security specialist from the Office of Nuclear Reactor Regulation, and three NRC contractors. This inspection focused specifically on the licensee's revised protective strategy to defend against NRC's design basis threat.

- The licensee's revised protective strategy was determined to provide an effective contingency response capability, with some weaknesses (Safeguards Information) being identified in one element of the strategy (Section S2.1).
