Subject: Change of Ownership Application

1. *The new name of the licensed organization. If there is no change, the licensee should so state.*

Asten Inc. of Charleston, SC and JWI Group of Jonesboro, GA have merged forming a new organization, AstenJohnson Inc., headquartered in Charleston, SC. Both former companies have long been users of portable nuclear instruments – namely the NDC Gamma Gauge Model 104 – to perform diagnostic services at customer paper mill sites. The purpose of this Change Application is to establish a single licensee and RSO location for the administration and control of all instruments.

2. *The new licensee contact and telephone number(s) to facilitate communications.*

3. *Any changes in personnel having control over licensed activities (e.g., officers of a corporation) and any changes in personnel named in the license such as radiation safety officer, authorized users, or any other persons identified in previous license applications as responsible for radiation safety or use of licensed material. The licensee should include information concerning the qualifications, training, and responsibilities of new individuals.*

Karen Minnis, the newly designated RSO, has held various responsibilities in Information Technologies and Technical Field Support for the past 10 years for the former Asten, Inc. She is now a member of the Papermaking and Diagnostic Services Team of AstenJohnson, Inc. which handles all specialized technical field support. A certified and licensed gamma gauge user, Karen has recently completed Engelhardt & Associates Radiation Safety Course as an additional informational resource in preparation for this new responsibility. Already well acquainted with the former Asten, Inc. Gamma Gauge User Program, she is now interfacing with the former JWI Group, Inc. Program and developing a totally unified approach for AstenJohnson, Inc.

4. *An indication of whether the transferor will remain in non-licensed business without the license.*

Per Item 1. above, AstenJohnson is a merger of former competitors to produce a single, stronger union to better serve the same papermaking industry. All diagnostic service

functions will continue to be performed by the same personnel using the same nuclear instruments (gamma gauges).

5. *A complete, clear description of the transaction, including any transfer of stocks or assets, mergers, etc., so that legal counsel is able, when necessary, to differentiate between name changes and changes of ownership.*

The former companies, both private corporations, officially merged on September 13, 1999. A copy of the official notice is included, see Attachment B.

6. *A complete description of any planned changes in organization, location, facility, equipment, or procedures (i.e., changes in operating or emergency procedures).*

As previously indicated, the major changes associated with this application are the principle location of the new merged company and the RSO. Some minor changes have also occurred in the combined license user list due to consolidation and realignment of field personnel. It should be noted that Charleston is the corporate headquarters of AstenJohnson, Inc. and Summerville and Walterboro are immediate operational sites for the company.

7. *A detailed description of any changes in the use, possession, location, or storage of the licensed materials.*

A list of the current AstenJohnson, Inc. assigned gauge custodians is attached, see Attachment C. Again, these changes have been made as a result of the re-deployment of field personnel. All licensed personnel are well versed in the specific responsibilities of gauge use, safety and storage. The listed custodians are the principle users of their respective assigned gauges, although other licensed personnel within the region may also be users.

8. *Any changes in organization, location, facilities, equipment, procedures, or personnel that would require a license amendment even without the change of ownership.*

All of the changes are associated with the merger.

9. *An indication of whether all surveillance items and records (e.g., calibrations, leak tests, surveys, inventories, and accountability requirements) will be current at the time of transfer. A description of the status of all surveillance requirements and records should also be provided*

The surveillance records of Asten and JWI have been maintained in current fashion during this transition stage, see Attachment D.

10. *Confirmation that all records concerning the safe and effective decommissioning of the facility, pursuant to 10 CFR 30.35(g), 40.36(f), 70.25(g), and 72.30(d); public dose; and waste disposal by release to sewers, incineration, radioactive material spills, and on-site burials, have been transferred to the new licensee, if licensed activities will continue at the same location, or to the NRC for license terminations.*

There will be no change in the total number of gauges - all portable devices - formerly owned by Asten, Inc. and JWI Group, Inc., individually. Any decommissioning, should it

be required for service repair reasons, would be handled only by the manufacturer of gauge – NDC, Monrovia, CA.

11. *A description of the status of the facility. Specifically, the presence or absence of contamination should be documented. If contamination is present, will decontamination occur before transfer? If not, does the successor company agree to assume full liability for the decontamination of the facility or site?*

All subject gauges are portable devices and when not being used for diagnostic purposes are transported via custodian vehicle, shipped only via FedEx, or stored at the custodian's assigned location. Leak tests are routinely performed and reported and any damage / contamination would be immediately addressed by the custodians and reported to the RSO. AstenJohnson assumes full liability for any contamination problems associated with any gauge presently owned by Asten or JWI.

12. *A description of any decontamination plans, including financial assurance arrangements of the transferee, as specified in 10 CFR 30.35, 40.36 and 70.25. This should include information about how the transferee and transferor propose to divide the transferor's assets and responsibility for any cleanup needed at the time of transfer.*

As mentioned previously, all gauges now owned by Asten, Inc. and JWI Group, Inc. will be owned by AstenJohnson, Inc. Although no cleanup problems are known to exist, AstenJohnson, Inc. assumes full liability for any problems associated with gauges now owned by Asten, Inc. and JWI Group, Inc..

13. *Confirmation that the transferee agrees to abide by all commitments and representations previously made to NRC by the transferor. These include, but are not limited to: maintaining decommissioning records required by 10 CFR 30.35(g); implementing decontamination activities and decommissioning of the site; and completing corrective actions for open inspection items and enforcement actions.*

With regard to contamination of facilities and equipment, the transferee should confirm, in writing, that it accepts full liability for the site, and should provide evidence of adequate resources to fund decommissioning; or the transferor should provide a commitment to decontaminate the facility before change of control or ownership.

With regard to open inspection items, etc., the transferee should confirm, in writing, that it accepts full responsibility for open inspection items and/or any resulting enforcement actions; or transferee proposes alternative measures for meeting the requirements; or the transferor provides a commitment to close out all such actions with NRC before license transfer.

AstenJohnson, Inc. will abide by all commitments and representations previously made to the NRC and accepts full liability for any problems arising from the transfer of gauges from Asten, Inc. and JWI Group, Inc. Further, AstenJohnson, Inc. accepts full responsibility for resolving any open inspection items which may exist at the time of this requested change of ownership.

14. *Documentation that the transferor and transferee agree to the change in ownership or control of the licensed material and activity, and the conditions of transfer; and the transferee is made aware of all open inspection items and its responsibility for possible resulting enforcement actions.*

Asten, Inc. and JWI Group, Inc. have agreed to and are merged into AstenJohnson, Inc. and the new entity, as previously stated, accepts full responsibility and liability for any and all open inspection issues which may exist at the time of this requested change of ownership.

15. *A commitment by the transferee to abide by all constraints, conditions, requirements, representations, and commitments identified in the existing license. If not, the transferee must provide a description of its program, to ensure compliance with the license and regulations.*

AstenJohnson, Inc. will abide by all issues stated above, and as identified in the existing licenses held individually by Asten, Inc. and JWI Group, Inc.

CHARLESTON, SC and KANATA, ON – The merger of Asten and JWI Group was completed September 8, announces William A. Finn, Chairman and CEO of the newly formed AstenJohnson.

The new organization, which is a major supplier to the paper industry, is well positioned to broaden product capability, strengthen research and development efforts, and enhance worldwide distribution. Along with its European-based partner, Heimbach, AstenJohnson will provide its customers with a strong global supplier.

With the completion of the merger, all paper machine clothing, specialty fabrics/filtration and filaments plants will operate under the AstenJohnson name. Johnson Foils will retain its name as a division of AstenJohnson.

North American plants are in Georgia, Massachusetts, Pennsylvania, South Carolina, Vermont, Wisconsin, Ontario and Quebec. Corporate headquarters are in Charleston with Canadian headquarters in Kanata. Heimbach has plants in Germany, Belgium, England, Ireland, Spain and Switzerland.
