MEDICAL STATUS UPDATE

Gentlemen:

License condition three of the September 16, 1999, license amendment to Operator License No. SOP-20811-1 (NRC Docket No. 55-20807) for the Brunswick Steam Electric Plant (BSEP), Unit Nos. 1 and 2, states "You shall submit an annual medical status report in July 2000 from your personal physician and/or neurologist." As required by this license condition, Carolina Power & Light (CP&L) Company is submitting a status report on the medical condition of the individual holding this license. A medical status report dated July 11, 2000, is enclosed, accompanied by the requisite NRC Form 396. The attending physician has determined the licensee to be capable of safely operating a reactor and recommends that the existing license conditions continue. Additionally, the NRC Form 396 proposes that the individual's license conditions (i.e., license condition number three) be amended as follows:

You shall submit an annual medical status report in the month of July from your personal physician and/or neurologist.

CP&L requests that the information in the enclosures be withheld from public disclosure in accordance with 10 CFR 2.790(a)(6), since disclosure of this information would constitute a clearly unwarranted invasion of personal privacy.
