Organization of Agreement States 2000 Annual Meeting

October 2 - 4, 2000

Charleston, South Carolina

The officers of the Organization of Agreement States (OAS) and the South Carolina Department of Health and Environmental Control's (DHEC) Bureau of Radiological Health would like to invite you to attend the 2000 annual meeting in Charleston, S.C. The meeting dates are October 2 - 4, 2000.

We have secured the Doubletree Guest Suites Hotel, 181 Church Street, in historic downtown Charleston. This all-suites hotel is located within a very short walking distance to most restaurants, shopping, and historical sites. Room rates are at the federal per diem rate of \$99 per day plus 12% tax. Underground parking is available for \$12 per day plus tax but cars are not needed. Reservations must be made by Friday, September 1, 2000. The toll free number for the hotel is 877-408-8733 or 843-577-2644. Please refer to DHEC/OAS when making reservations. Unfortunately, there are very few rooms available at this rate for the preceding Saturday. We can provide the names of other hotels in the area if needed for Saturday.

Charleston International Airport is served by U.S. Airways, Delta, Continental, United Express, and Midway Corporate Airlines. Shuttle van and taxi service is available outside the baggage claim area. Rates are approximately \$20 for a one-way fare.

There will be a \$50 registration fee required. This will cover the costs of the meeting rooms, breaks, and reception. There will be a reception in the courtyard Monday evening, October 2 that will feature a South Carolina Low-country stew and a cash bar. Morning breaks will include pastries or cinnamon rolls. Registration should be sent by September 15, 2000. We will also have on-site registration. Receipts will be given out at the meeting.
