Dear Dr. Patrick:

Our letter dated June 7, 2000, with the subject same as above, is cancelled entirely. Therefore, this letter transmits revised modification number 9 to Task Order No. 17 under contract NRC-02-96-004.

The subject task order expired on September 30, 1999, and we are initiating closeout action. However, pending completion of all closeout requirements, it is necessary to deobligate excess funds remaining under the task order for other immediate agency requirements. The purpose of modification no. 9 is to decrease the Task Order ceiling and obligated amount by \$11,852.97 as follows:

The cost ceiling associated with performance of Task Order No. 009 is hereby decreased by \$11,852.97 from \$67,922.00 to \$56,069.03.

The estimated reimbursable costs and the cost of facility capital in the amount of \$63,032.00 are hereby decreased by \$11,852.97 to \$51,179.03.

The Fixed Fee, in the amount of \$4,890.00 remains the same.


