The purpose of this modification is to deobligate FY'00 funds in the amount of \$10,000.00, thereby decreasing the obligated amount of the subject contract from \$45,000.00 to \$35,000.00. Accordingly, the following change is hereby made:

Subsection B.4 - CONSIDERATION AND OBLIGATION - CEILING is deleted in its entirety and the following is substituted in lieu thereof:

**"CONSIDERATION AND OBLIGATION -- CEILING  
(JUN 1988)**

- a. The total amount to the Government for the work specified in Section C herein shall not exceed \$77,232.40.
- b. The amount presently obligated with respect to this contract is \$35,000.00. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

A summary of obligations for this task order from award date through the date of this action is given below:
