

This modification confirms the March 31, 2000, verbal authorization provided to David W. Weeks, of the Institute of Nuclear Power Operations, to commence work effective April 2, 2000, under Option Year Three of this contract with a temporary ceiling of 50,000.00.

Accordingly, the Government hereby exercises Option Year Three to extend the term of this contract for one additional year, through April 1, 2001, in accordance with Subsections F.2 - DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE II (MAR1987) and I.4 - 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 1989). Work during this period shall be performed as specified under Subsection C.1 - STATEMENT OF WORK of this contract and in accordance with Subsection B.2 - BRIEF DESCRIPTION OF WORK (MAR 1987) and Subsection B.2.1 SUPPLIES OR SERVICES AND PRICES/COSTS, OPTION YEAR THREE PERIOD.

It is hereby noted that there are currently \$35,491.90 of unexpended funds remaining under the base year period which are being used to fund the third option period under this contract. Therefore, Subsection B.2.1 SUPPLIES OR SERVICES AND PRICES/COSTS, BASE YEAR PERIOD is also being revised to reflect a decrease in the ceiling amount of the basic contract period by \$35,491.90 to allow these funds to be used during this option period. As a result, this modification will only obligate \$189,508.10 to fully fund the third option year period as agreed to in the Contractor's March 31, 2000, letter which is attached hereto and made a part hereof.

Accordingly, this contract is hereby modified as follows:

1. Subsection B.2.1 SUPPLIES OR SERVICES AND PRICES/COSTS, BASE YEAR PERIOD is hereby deleted in its entirety and substituted with the following in lieu thereof:

2. Under Subsection B.2.2 CONSIDERATION AND OBLIGATION—FIXED PRICE, the paragraphs entitled BASE PERIOD and TOTAL OBLIGATIONS are hereby revised to read as follows:

"BASE PERIOD

- A. The firm fixed price portion for CLIN 0002 is \$6,500.00
- B. CLIN 0001 is priced on a fixed unit price basis with estimated hours of use. The actual amount for CLIN 0001 is \$8,176.10.

The amount presently obligated under CLIN 0001 is \$8,176.10.

TOTAL OBLIGATIONS

The amount presently obligated for all services under this contract is \$448,676.10"

2. Subsection F.2 - DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987) is hereby deleted in its entirety and substituted with the following in lieu thereof:

"F.2 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)

This contract shall commence on July 2, 1997, and will expire on April 1, 2001. The term of this contract may be extended at the option of the Government for an additional 1-year option period."

All other terms and conditions of this contract remain unchanged.
