ENTITLED, "OVERSIGHT ASSISTANCE TO UKRAINE - SNRA AND SSTC
REVIEWS"

Dear Mr. Kellogg:

This letter definitizes Modification No. 1 to Task Order No. 9, which exercises Optional Subtask 4 under the statement of work, extends the period of performance through July 31, 2000, and provides incremental funding in the amount of \$42,837.00. Accordingly, Task Order No. 9 is modified as follows:

Paragraph 2 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 9 shall be in effect from March 27, 2000, through July 31, 2000, with a cost ceiling of \$156,417.00. The amount of \$144,031.00 represents the total estimated reimbursable costs and the amount of \$12,386.00 represents the fixed fee. Task Order No. 9 also contains one optional subtask. If exercised, the total estimated cost to the Government for full performance of Optional Subtask 5 is \$44,068.00, of which the amount of \$40,578.00 represents the total estimated reimbursable costs and the amount of \$3,490.00 represents the fixed fee. "

Paragraph 4 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"The amount currently obligated by the Government with respect to this task order is \$142,837.00, of which \$131,526.00 represents reimbursable costs and the amount of \$11,311.00 represents fixed fee. It is estimated that the amount currently allotted will cover performance through July 24, 2000."


