The purpose of this Modification No. 8 is to exercise the option to extend the term of the contract and provide additional funding. Therefore, the following changes are hereby made:

1. Section B.4 CONSIDERATION OBLIGATION --DELIVERY ORDERS, paragraphs "a." and "b." are revised to read as follows:

**"B.4. CONSIDERATION OBLIGATION -- DELIVERY ORDERS**

- a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$439,977.00. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.
- b. The amount presently obligated with respect to this contract is \$358,213.00. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a. above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

2. Section F.2 DURATION OF CONTRACT PERIOD is revised to read as follows:

**"F.2 DURATION OF CONTRACT PERIOD**

The ordering period for this contract shall commence on 7/07/97 and will expire on 7/6/01. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional 1 year."
