Dear Mr. Kellogg:

This letter definitizes Modification No. 2 to Task Order No. 9, which exercises Optional Subtask 5 under the statement of work, extends the period of performance through August 31, 2000, and provides incremental funding in the amount of \$44,068.00. Accordingly, Task Order No. 9 is modified as follows:

Paragraph 2 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 9 shall be in effect from March 27, 2000, through August 31, 2000, with a cost ceiling of \$200,485.00. The amount of \$184,609.00 represents the total estimated reimbursable costs and the amount of \$15,876.00 represents the fixed fee."

Paragraph 4 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"The amount currently obligated by the Government with respect to this task order is \$186,905.00, of which \$172,104.00 represents reimbursable costs and the amount of \$14,801.00 represents fixed fee. It is estimated that the amount currently allotted will cover performance through August 24, 2000."


