SUBJECT: MODIFICATION NO. 1 TO TASK ORDER NO. 3 ENTITLED "UPDATE REG GUIDES 5.32 AND 5.65" UNDER CONTRACT NRC-02-98-006

The purpose of this task order modification is to set forth a settlement agreement on estimated cost and final fixed fee as a result of a termination notice issued by the Contracting Officer by email effective February 28, 2000 pursuant to FAR 52.249-6. Accordingly, the task order is modified as follows:

Task Order No. 3 was in effect from January 14, 2000 to February 28, 2000. The total cost plus fixed fee for this task order is decreased by \$61,716 from \$75,454 to \$13,738 of which the amount of \$12,950 represents the reimbursable costs, and the amount of \$788 represents the fixed fee. All costs incurred including settlement costs with the exception of possible indirect rate adjustments have been vouchered out as of invoice no. 3 dated 4/20/2000. \$2,383 of the estimated cost of \$12,950 is reserved for possible adjustment to the indirect costs incurred upon establishment of final indirect rates in accordance with FAR 52.216-7. 15% of the fixed fee amount shown above will be retained pending closeout and final release of the contract.

Funds in the amount of \$61,716 are deobligated from this task order.


