Upon consideration of the August 14, 2000 joint report from applicant Private Fuel Storage, L.L.C., (PFS), intervenor State of Utah (State), and the NRC staff regarding scheduling relating to the submission of a sample Service Agreement in accordance with the Commission's August 1, 2000 directive, CLI-00-13, 52 NRC __ (Aug. 1, 2000), it is

ORDERED, that applicant PFS shall submit its sample Service Agreement on or before Friday, September 29, 2000. The Board will issue an additional scheduling order regarding other party submissions in connection with the sample Service Agreement at a later date.¹
