**SUBJECT: SECOND QUARTER 2000 ASSESSMENT FOLLOWUP - WATERFORD  
STEAM ELECTRIC STATION, UNIT 3**

Dear Mr. Dugger:

Our review of second quarter performance indicators and inspection findings for your Waterford Steam Electric Station, Unit 3, identified that all performance indicators and findings were green. No new adverse trends were identified.

However, one significant finding from NRC Inspection Report 50-382/00-03 was identified prior to the implementation of the revised reactor oversight program and was dispositioned during this quarter using the previous reactor oversight process. On March 20-23, 2000, the NRC identified significant weaknesses in your physical security program and your staff's capability to respond adequately to a design basis intrusion. Although you have taken interim compensatory measures to address these concerns, the NRC issued a Confirmatory Order on August 4, 2000, to assure that corrective actions are effectively implemented over the long term. In part, this order requires you to demonstrate your ability to protect the plant against the design basis threat by conducting force-on-force exercises that will be evaluated by the NRC. We plan to perform Inspection Procedure 81110, "Operational Safeguards Response Evaluation (OSRE)," to evaluate these exercises. This letter is to confirm that we intend to perform this followup inspection at your facility during January 2001.
