This is a follow-up to our July 25, 2000, telephone conversation regarding your e-mail to Mr. Mark Lesser of the NRC staff dated June 1, 2000, in which you expressed safety concerns surrounding the use of depleted uranium munitions by the U.S. Department of Defense. During that conversation, I offered you an opportunity to make a presentation on your concerns to an NRC Petition Review Board. I asked you to contact us weekly concerning arrangements for your presentation. We have not heard from you, and on July 31, 2000, a member of my staff tried to contact you but found that the telephone was disconnected. Please contact us as soon as possible so that you and members of my staff can arrange a date and time, if you still wish to make a presentation. If you are unable to schedule a presentation within a reasonable period of time, we will proceed to review your concerns without a presentation.
