

The purpose of this modification is to provide incremental funding in the amount of \$25,000.00, thereby increasing the contract's obligated amount from \$598,284.12 to \$623,284.12. Accordingly, the contract is hereby modified as follows:

Under Subsection B.3 entitled "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE" (JUN 1988) ALTERNATE 1 (JUN 1991), paragraphs (c) and (d) are deleted in their entirety and substituted with the following in lieu thereof:

- "(c) The amount currently obligated by the Government with respect to this contract is \$623,284.12, of which the sum of \$573,109.75 represents the estimated reimbursable costs, and of which \$50,174.37 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through September 15, 2000."

All other terms and conditions of the contract remain unchanged, including the ceiling amount of \$670,129.48.
