Subject: Nevada Regulation Update

Prior to the last interim NRC visit in December 1999 when I had to miss the meeting with you, Larry Boschult committed to you that we will try to incorporate NRC's compatibility concerns of our regulations by January 2001.

Recall that we solicited NRC's review/comments prior to our last adoption around December 1998, only to get NRC's comments three months AFTER our completed adoption. We thought we had it wired and definitely had our affected regulated community and administration satisfied, only to find out that NRC had objection after the fact to what was adopted by the Nevada State Board of Health.

I Am requesting that you agree to an extension of intended completion by September 30, 2001. We have recently had our opportunities for rule adoption further constrained by our Governor and legislative process so that there is now only a very specific time window in the 2-year legislative cycle when we can go for rule adoption without having to do it a second time to make it permanent.

As it stands, we have gone there once, only to hear NRC is not happy with what we did. If we proceed now to promulgate what you want anytime between now and around June 2001, the regulations will only be temporary and we will have to return for second permanent adoption in the following 6 - 12 months anyway. Adoption after July 1, 2001 through June 30, 2002 will be permanent without a second process before the board including all the public hearings, reviews by lawyers, legislative counsel bureaus, governors, etc. Basically, adoption during the 12 months following July 1 of the odd-numbered years is the only time that a permanent regulation is adopted. Any other time requires a second adoption process during the prescribed time anyway.

With this in mind, frankly, I would now intend to look at the NRC compatibility calendar to try to incorporate any other necessary NRC regulations through 2002 so that our next proposal for rule updates is not until 2003. Can you help us to ensure we have that extended calendar. Larry B. tells me that the most current thing we have is the calendar from Kevin Hsueh at the last meeting which only goes through year 2000.

If you want this request for time extension on official agency letterhead or in shorter form, let me know. What say ye?
