The purpose of this modification is to deobligate excess funds in the amount of \$18,455.03 remaining under the expired contract. Accordingly, the contract is modified as follows:

Section B.3 "Consideration and Obligation - Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991)," paragraph f is deleted and substituted with the following:

- "f. The amount currently obligated by the Government with respect to this contract is \$9,837.97, of which the sum of \$7,986.97 represents the estimated reimbursable costs, and of which \$1,851.00 represents the fixed fee."
