Upon consideration of (1) intervenor State of Utah's August 31, 2000 motion for leave to reply to the August 30, 2000 responses of applicant Private Fuel Storage, L.L.C., (PFS) and the NRC staff to the State's August 2, 2000 request to admit late-filed contentions Utah LL through Utah OO, including the representations therein regarding those parties' positions on the State's motion; and (2) the August 28, 2000 filings by PFS, the State, and the staff in which they discuss the impact of the Commission's decision in CLI-00-13, 52 NRC __ (Aug. 1, 2000), on the matters that are the subject of the parties' July 31, 2000 proposed findings of fact and conclusions of law relating to the issues considered in the Board's June 2000 evidentiary hearing sessions, it is

ORDERED, that the State's August 31, 2000 motion for leave to file a reply is granted and its reply shall be filed on or before Thursday, September 7, 2000, and it is

FURTHER ORDERED, that on or before Monday, September 11, 2000, PFS, the State, and the staff may submit filings, not to exceed ten pages in length, responding to the other

parties' discussions regarding the impact of CLI-00-13, including the State's suggestions regarding the adoption of additional license conditions.
