## SYNOPSIS

The Office of Investigations, U.S. Nuclear Regulatory Commission (NRC), Region II, initiated this investigation on December 15, 1999, to determine whether Florida Power and Light Company (FPL), an NRC licensee, illegally discriminated against a St. Lucie Nuclear Plant instrumentation and control technician because he engaged in activity protected under Section 211 of the Energy Reorganization Act and 10 CFR 50.7.

The evidence developed did not substantiate the allegation that FPL illegally discriminated against the alleged.
