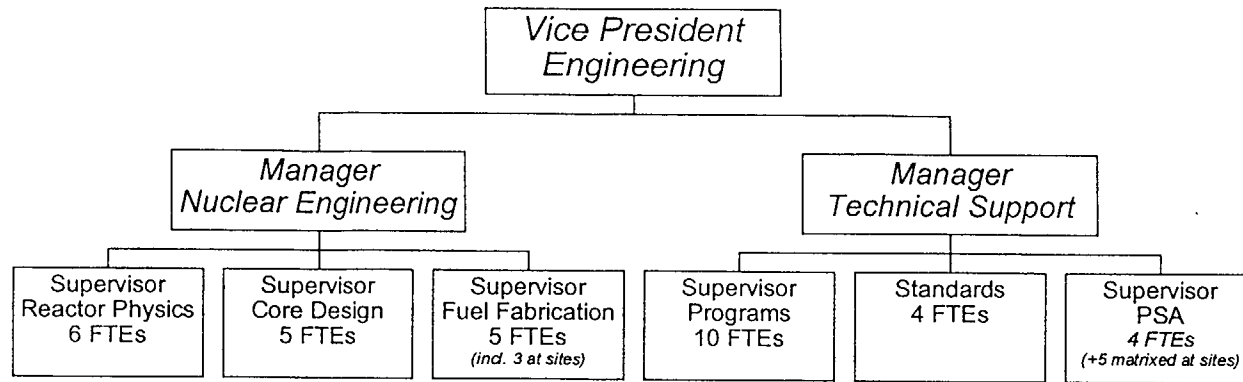

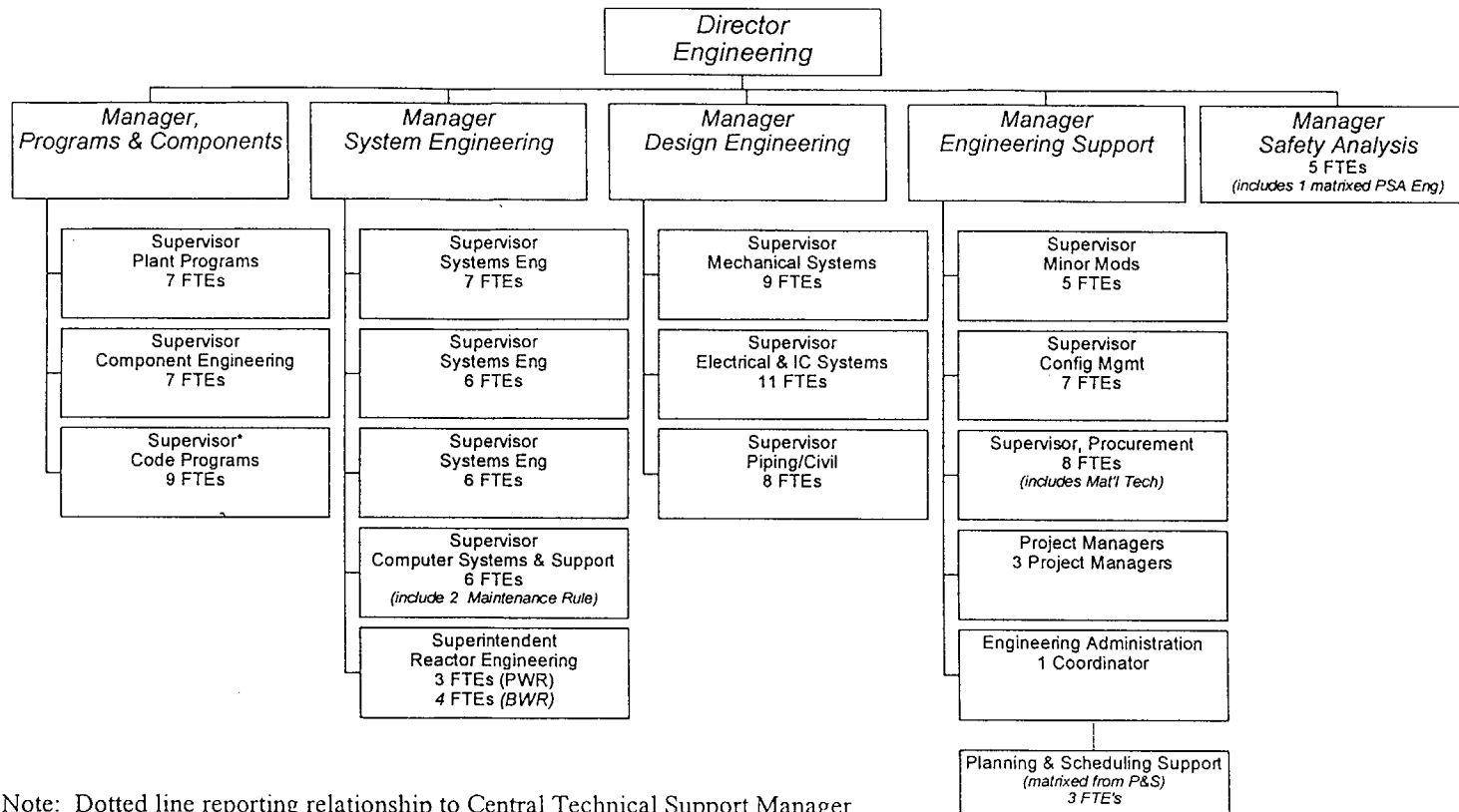

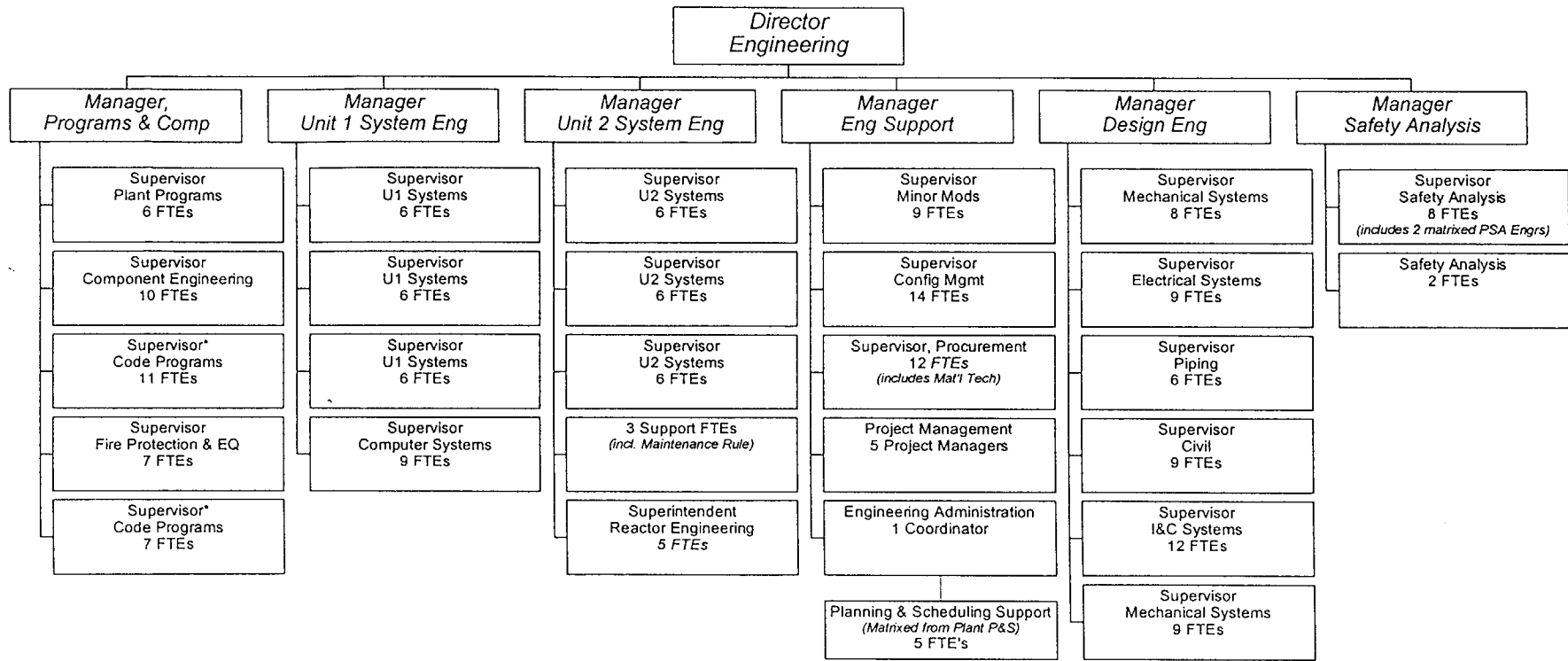
EOI Engineering (Single Unit Site)

EOI Engineering (ANO)

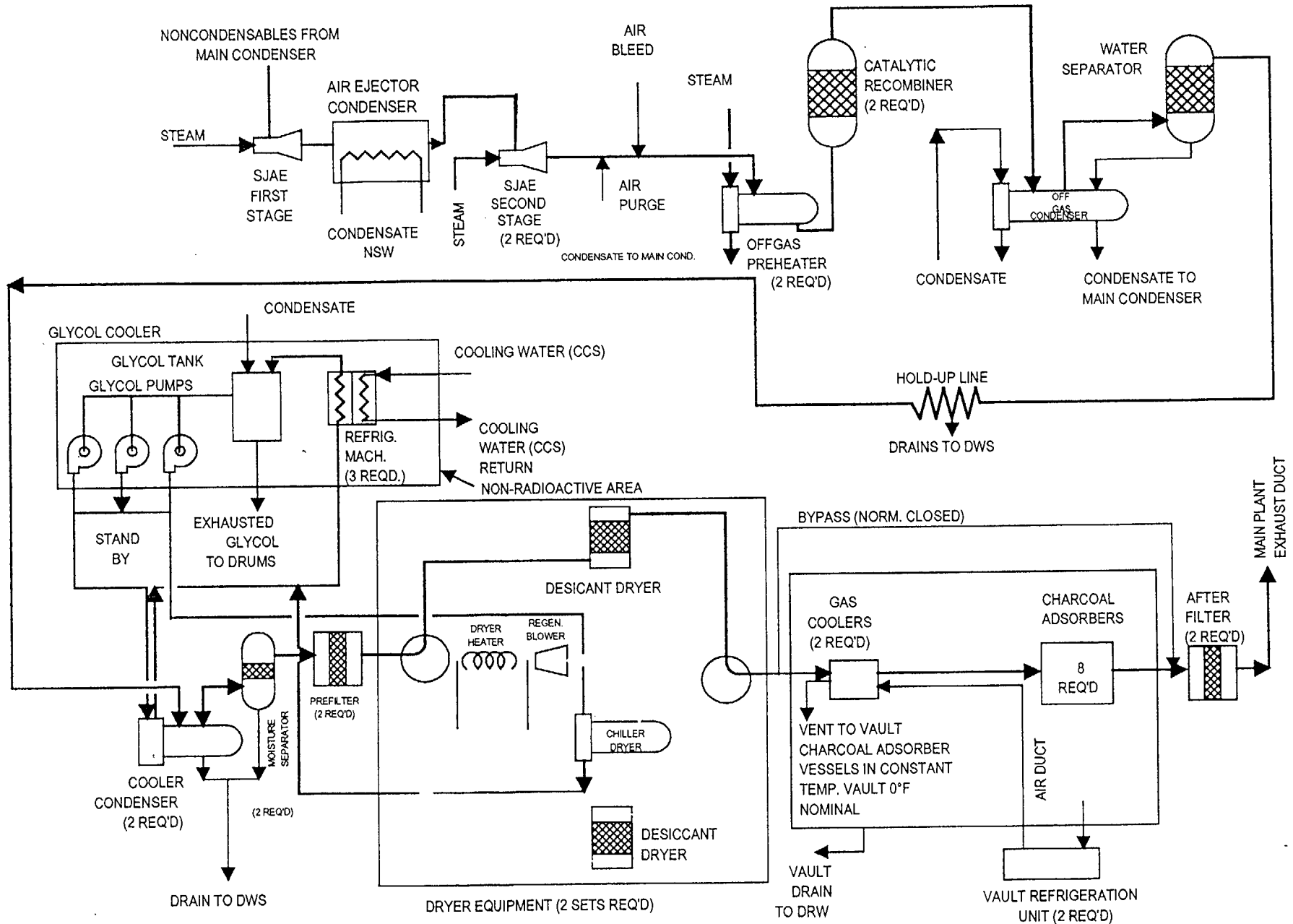
