
The annual site inspections for the Tuba City, Arizona, and Mexican Hat, Utah disposal sites are scheduled for September 13 and 14, respectively.

Long-Term Surveillance and Maintenance Program (LTSM) personnel will leave Grand Junction on the morning of September 13 and will begin the site inspection at the Tuba City site at approximately 1:00 p.m. Program staff will tentatively stay at the San Juan Inn in Mexican Hat that night. The staff will inspect the Mexican Hat site on the morning of September 14 and return to Grand Junction that night.

The inspectors will request an orientation briefing of the ground water pump and treat system at Tuba City and will not inspect all outlying wells because of constant DOE presence at that site. Inspectors will not inspect all the seeps associated with the Mexican Hat site because they are sampled quarterly.
