Please do not approve the plan to locate High Level Nuclear Waste on the Goshute Reservation in Skull Valley Utah.

Despite the claims of cask safety, as well as the rhetoric about this being only a temporary storage facility until Yucca Mountain is operational, I oppose the transportation and storage of these materials on the Goshute Reservation site.

There is no solid evidence that the casks will remain stable under prolonged exposure to the heat and radiation caused by the spent fuel rods.

There is evidence of fault activity in close proximity to the proposed storage facility.

There is military activity (an active bombing range) within a few miles of the proposed facility.

All of these conditions pose a significant threat of an accident of prodigious magnitude. And despite claims of the relative probability of such an accident occurring, I oppose creating the conditions under which just such an occurrence might happen.

DO NOT LOCATE THE HIGH LEVEL NUCLEAR WASTE IN SKULL VALLEY!!
