Dear Sir or Madam:

Pursuant to the Freedom of Information Act, 5 U.S.C. § 552 ("FOIA") and 10 C.F.R. Part 9, I request, on behalf of my client Curtis C. Overall, the records described below that are in the possession, custody or control of the United States Nuclear Regulatory Commission ("NRC") including, but not limited to, the NRC Office of the Inspector General ("NRC OIG") and the NRC Region II Office of Investigations ("NRC Region II OI").

The records I request include every writing of every type and description, and every other instrument or device by which, through which, or on which information has been recorded, preserved, or transmitted, including but not limited to memoranda, notes, letters, drawings, files, graphs, charts, maps, photographs, agreements, contracts, telephone messages, e-mail messages, handwritten notes, diaries, logs, calendars, ledgers, studies, data sheets, computations, calculations, accounting(s), financial statements, tax forms, voice recordings, medical records, computer tapes or disks, and other data compilations.

Specifically, I am requesting, for the period of January 1, 1995, to the present, all documents and communications¹

¹"Communications" shall mean any communication, discussion, statement, conversation, contact, letter, memorandum, telephone call, message or direction, whether written or oral, and whether in person, by telephone, by telecopier, or by mail, including e-mail.

concerning or relating to Mr. Overall or any NRC investigations or inquiries begun or initiated as a result of, or in connection with, Mr. Overall's activities, reports or communications. These include, but are not limited to, any investigation conducted by the NRC OIG and/or the NRC Region II OI, including all allegations regarding the conduct of the investigation(s) undertaken by the NRC Region II OI into Mr. Overall's claims of harassment and intimidation.

I am also requesting all documents reflecting communications between the Tennessee Valley Authority ("TVA") and its agents or entities and the NRC related to these investigations.

My client will pay the reasonable and normal search and copying fees to obtain the above-described documents.

For documents or portions of documents which you withhold pursuant to a specific exemption of FOIA, please provide an index itemizing and describing the documents which have been withheld and a detailed justification for the grounds for claiming each exemption. Vaughn v. Rosen (I), 484 F.2d 820, 827-28 (D.C. Cir. 1973).

I look forward to hearing from you within ten days.
