SUMMARY: The plant entered the month operating at 100% power. TMI-1 operated at nominal full power throughout the month with the exception of two time periods. The first occurred from 13:30 to 16:05 on October 27, when power level was reduced by approximately eight MWe for control rod movement surveillance. The second power reduction occurred from 08:18 to 10:32 on October 28, when power level was reduced by about 10% for main turbine control valve testing. Both of these evolutions were planned. The plant ended the month operating at 100% power.
