Gentlemen:

Enclosed are the original and three copies each of Revision 20 of the Waterford 3 Physical Security Plan (Enclosure 1), Revision 7 of the Waterford 3 Safeguards Contingency Plan (Enclosure 2) and Revision 7 of the Security Training and Qualification Plan (Enclosure 3), which are submitted in accordance with 10CFR50.54(p). The plan revisions were approved on November 10, 2000 and November 15, 2000. This submittal is provided under affidavit per requirements of 10CFR50.

The Waterford 3 Plant Operations Review Committee has concluded that the revisions to the Waterford 3 Physical Security Plan, Safeguards Contingency Plan, and Security Training and Qualification Plan do not constitute a decrease in the safeguards effectiveness of the plans. These revisions incorporate an enhanced defensive strategy that increases the numbers of armed responders and replaces the shotgun with a semi-automatic rifle as the contingency response weapon, as well as reformatting the plans in accordance with plant procedures.
