RALLY AGAINST NUCLEAR WASTE EXPANSION

Second Phase of Nonviolent Civil Disobedience to Occur

A significant crowd is set to gather for a rally and protest against Carolina Power & Light's proposed expansion of high-level nuclear waste at its Shearon Harris Nuclear Power Plant. A number of protesters, including students, elders and NC WARN members will implement the second round of the nonviolent civil disobedience campaign at the rally.

Church, and Cynthia Brown of Southerners for Environmental Justice and former Durham City Councilwoman. There will be performances by musical guests Jon Shain, Cindy Bolton & Co. and the Raging Grannies. The giant puppets of Donovan Zimmerman will also be featured.

Members of NC WARN and Coalition Against Nuclear Imports to the Triangle (CANIT) launched a campaign of nonviolent civil disobedience against CP&L in October, calling for the company to halt its 2-year opposition to safety hearings on its proposed expansion. Three citizens were arrested, as they sought to meet with CP&L CEO William Cavanaugh. They wanted his signature on a formal statement agreeing to stop the company's legal offensive to prevent hearings. A larger round of civil disobedience is scheduled for Sunday's rally.


