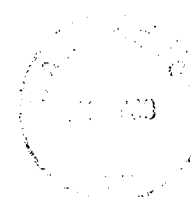
OMB has completed the review and consultation process for your Year 2000 Commercial Activities Inventory, as required under the Federal Activities Inventory Reform Act of 1998 (the FAIR Act). Under the Act, OMB is required to publish a notice in the *Federal Register* indicating that the inventory is available to the public from the agency. My staff has informed me that you are prepared to have your inventory publicly available when OMB's notice-of-availability is published in the *Federal Register* in the next several weeks. The inventory is to be made available through your Washington, DC or national headquarters offices and will be ready for pick-up by the public, mailing, e-mailing or faxing, and will be posted on your web site on the date of the *Federal Register* notice. Phone numbers manned by individuals who can answer questions regarding the Inventory will be provided to OMB and published with the *Federal Register* notice. You must also transmit a copy of the inventory to Congress.

The date of publication of OMB's *Federal Register* notice marks the start of the statutory 30-day interested party challenge process permitted under the Act. Guidance on this aspect of the FAIR Act and additional agency responsibilities are specified in Appendix 2, Paragraphs G, H and I of the Revised Supplemental Handbook to OMB Circular No. A-76, as revised by Transmittal Memorandum 20 to Circular A-76, dated June 14, 1999, and as contained in Sylvia Mathews' Memorandum to Heads of Agencies (M-00-11) dated April 27, 2000.
