Chairperson Geneal Anderson invited the cooperating Federal agencies to discuss the consultation process required by Section 106 of the National Historic Preservation Act and the potential impacts to cultural resources as a result of the Private Fuel Storage proposal for the construction and operation of an independent spent fuel storage installation on the Reservation of the Skull Valley Band of Goshute Indians and the related transportation facility in Tooele County, Utah.

The cooperating Federal agencies requested specific knowledge of historic properties of cultural and traditional significance within the Area of Potential Effect (APE) and inquired if the Tribal Council was aware of any cultural and traditional significance attached to an unevaluated Rock Alignment and Cairn located within the APE. The Tribal Council indicated that they were not aware of any information on properties of cultural and traditional significance within the APE.
