SUBJECT: SUMMARY OF DECEMBER 6, 2000, MEETING WITH AMERGEN REGARDING  
STATUS OF LICENSING ISSUES AT TMI-1

On December 6, 2000, a public meeting was held between the U. S. Nuclear Regulatory Commission (NRC) and AmerGen (the licensee), at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland. The purpose of the meeting was to discuss the quarterly status and completion schedule of active, and soon to be submitted, TMI-1 licensing issues. Enclosure 1 is a list of attendees. Enclosure 2 is a copy of the licensee's handout used at the meeting.

Major changes since the previous meeting in September 2000:

Completed NRC staff actions:

The staff issued License Amendment No. 225 on September 25, 2000, in response to the licensee's Technical Specification Change Request (TSCR) No. 262 which requested standard technical specification (STS)-like improvements to the TMI-1 TSs, and closed related TAC (task assignment control) No. MA5185.

The staff issued its approval on October 5, 2000, of the indirect license transfer resulting from the formation of Exelon Corporation following the merger of PECO and Unicom. This closed related TAC No. MA9525.

The staff issued License Amendment No. 226 on October 18, 2000, in response to the licensee's License Change Application (LCA) No. 289 which requested changes to the air treatment systems TSs activated charcoal testing in accordance with Generic Letter 99-02. This closed TAC No. MA7288.

Other major changes:

The licensee identified several TSCRs and LCAs which it has not yet submitted and reviewed its submittal schedules and the date the submittal reviews would need to be completed. On many of these, the licensee indicated it would be requesting turn-around times of 6 months or less for the NRC to complete its review. The NRC staff reminded the licensee of its prioritization and related review schedules for incoming licensing actions and indicated that for some items it may be appropriate to allow for a longer review time than the licensee had anticipated.

The licensee indicated that for some forthcoming relief requests, it wanted to arrange a conference call in advance to discuss the issues, and facilitate communication and a better quality application. The NRC staff agreed and indicated it would try to arrange the requested calls.

The licensee had indicated that the indirect transfer of the operating license that was approved by the staff might occur as early as the end of the year, but has since indicated that it may now occur sometime later in the first quarter of 2001.
