In conformance with the Commission's policy on notification of the Licensing Board of new, relevant, and material information, this memorandum provides the information discussed below.

On August 7, 2000, the Board issued a Memorandum and Order (Ruling on Late-Filed Environmental Contentions), LBP-00-19, which admitted one late-filed environmental contention (EC-6) and established a schedule for its further litigation under 10 CFR Part 2, Subpart K. Written summaries were filed by all parties on November 20, 2000, and oral arguments were heard on December 7, 2000.

Under its regulations, the Commission may issue and make an amendment immediately effective, notwithstanding the pendency before it of a request for a hearing from any person, in advance of the holding or completion of any required hearing, where it has determined that no significant hazards considerations are involved. Accordingly, on December 21, 2000, the Commission issued a final no significant hazards consideration determination and license amendment to Carolina Power & Light Company (copy attached). This action was taken in response to the licensee's amendment application dated December 23, 1998, as supplemented. This action modified License No. NPF-63 for the Shearon Harris Nuclear Power Plant, Unit 1, by revising the Technical Specifications to support a modification to increase the spent fuel storage capacity by adding rack modules to spent fuel pools C and D and placing the pools in service.
