WPSC was succeeded by NMC, as the licensed operator of the Kewaunee Nuclear Power Plant (KNPP). By letter dated October 5, 2000, NMC (the licensee) requested the Nuclear Regulatory Commission (NRC) staff continue to process and disposition licensing actions previously docketed and requested by WPSC.

By letter dated June 7, 1999, as supplemented on February 4 and September 26, 2000, you applied for an amendment to the Kewaunee Nuclear Power Plant Operating License No. DPR-43. The proposed change would have modified the facility technical specifications pertaining to the existing KNPP reactor pressure vessel (RPV) pressure-temperature (P-T) limit curves. Subsequently, by letter dated December 18, 2000, you withdrew the amendment request; however, you did not withdraw the exemption requests. The exemption requests are being handled separately.

NOTICE OF WITHDRAWAL OF APPLICATION FOR

AMENDMENT TO FACILITY OPERATING LICENSE

The U.S. Nuclear Regulatory Commission (the Commission) has granted the request of Nuclear Management Company, LLC (the licensee) to withdraw the June 7, 1999, as supplemented February 4, and September 26, 2000, application for proposed amendment to Facility Operating License No. DPR-43 for the Kewaunee Nuclear Power Plant, located in Kewaunee County, Wisconsin.

The proposed amendment would have revised the Kewaunee Nuclear Power Plant Technical Specifications for the facility's reactor pressure vessel Pressure-Temperature limit curves.

The Commission had previously issued a Notice of Consideration of Issuance of Amendment published in the FEDERAL REGISTER on November 15, 2000 (65 FR 69061). However, by letter dated December 18, 2000, the licensee withdrew the proposed amendment change, but the licensee did not withdraw the exemption requests in the submittals dated June 7, 1999, as supplemented February 4, September 26, and December 18, 2000. The exemption requests are being processed separately.

For further details with respect to this action, see the application for amendment dated June 7, 1999, as supplemented February 4, and September 26, 2000, and the licensee's letter dated December 18, 2000, which withdrew the application for license amendment.
