ORDER

(Corrected Version of December 27, 2000 Order  
Granting Summary Disposition Filing Extension Motion)

Upon consideration of the December 26, 2000 motion of applicant Private Fuel Storage, L.L.C. (PFS), for an extension of time within which to file summary disposition motions relative to contention Utah K/Confederated Tribes B, Inadequate Consideration of Credible Accidents, and Utah L, Geotechnical, and there being no opposition thereto, it is

ORDERED, that the PFS December 26, 2000 motion for an extension of the filing dates for its summary disposition motions regarding contentions Utah K and Utah L is granted in that (1) the PFS dispositive motions shall be filed on or before Saturday, December 30, 2000; (2) party responses to those motions shall be filed on or before Saturday, January 20, 2001; and (3) a party response to any response in support of a PFS dispositive motion shall be filed on or before Wednesday, January 31, 2001.<sup>1</sup>

<sup>1</sup> Although it is not the general agency practice to establish filing deadlines on weekends or holidays, see 10 C.F.R. § 2.710 (for purpose of computing time, if last day of designated time period falls on weekend/holiday, period is extended to next business day), because the agency's rules of practice state that filing "is deemed to be complete as of the time of deposit in the mail," id. § 2.701(c), without differentiating between business days and weekends/holidays,
