

The purpose of this modification is to:

- (1) revise subsection B.3 CONSIDERATION AND OBLIGATION -- FIRM FIXED PRICE (JUN 1988) by (a) increasing the contract ceiling by \$46,858 from \$46,858.00 to \$93,716.00; and (b) providing funding which increases the contract obligated amount by \$46,858 from \$46,858.00 to \$93,716.00;
- (2) extend the period of performance; and
- (3) exercise the government's option of extending the term of the contract.

This modification also confirms the December 19, 2000, telecon between Mr. Donald A. King, NRC and Mr. Bill Cody, Encore Real Time, Inc., in which the contractor waived its right to a 60-day preliminary written notice of the exercise of this option. Accordingly, the contract is hereby modified as follows:

1. Under subsection B.3 CONSIDERATION AND OBLIGATION -- FIRM FIXED PRICE (JUN 1988) the sentence is deleted entirely and the following is substituted in lieu thereof:

The firm fixed price of this contract is \$93,716.00.

2. Under section F.2 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), delete the paragraph entirely and the following paragraph is substituted in lieu thereof:

This contract shall commence on the effective date of the contract and will expire two years after the effective date of the contract. The term of this contract may be extended at the option of the Government for an additional three (3) one-year options.

3. Under clause I.3, 52.217-9 - OPTION TO EXTEND THE TERM OF THE CONTRACT (NOV 1999) the Government hereby exercises its option to extend the term of the contract for one year.

A summary of obligations under this contract, from date of award through this modification, is given below:

This modification obligates FY01 funds in the amount of \$46,858.00

All other terms and conditions of the contract remain the same.
