Change In Criminal History Check Program Point Of Contact**

Pursuant to 10 CFR 73.57, Northeast Nuclear Energy Company (NNECO) is required to have a program for performing criminal history checks of individuals granted unescorted access to a nuclear power facility or having access to Safeguards Information. The Nuclear Regulatory Commission (NRC), Division of Facilities and Security, maintains a list of designated contacts for criminal history check information for all licensed facilities.


The Millstone criminal history check point of contact information has been revised to reflect new titles based upon a transition to a process based organization and relocation of access authorization functions formerly performed at the NNECO corporate office to the Millstone site.
